Qlik: The data analytics and visualization platform through which the SAMIEHD-Vis tool is run.

Widget: A simple interactive software application that can be embedded into a webpage. The widgets within SAMIEHD-Vis are listed below.

Widget/Link	Description
Filter by State	Selects the state(s) in which to load data. American Samoa, Washington DC, Guam, the Northern Mariana Islands, Puerto Rico, and the US Virgin Islands are included.
Filter by Year	Selects the year for which to display data, ranging from 2000 to 2023. Not all variables have data for all years, and for some variables, the values are averaged over multiple years.
Available Years Graphs	These show the years for which the X and Y variables have available data. If a variable's values are averaged together over multiple years, only one year will appear in the graph.
Loop Through Available Years	Displays the X and Y values for all years that they are available, but only if data is available for multiple years.
Variable X Dropdown	Selects an independent variable.
Variable Y Dropdown	Selects a response variable.
ESRI Maps	These interactive maps highlight counties based on their values for the X and Y Variable values. The X Variable is displayed on the left map, and the Y Variable is displayed on the right.
Scatter Plots	Plots a point for each county based on its value for the X and Y variables and allows the user to select specific data points for further analysis. <u>More information on scatter plots is available here.</u>
Data Table	Shows the X and Y value for each county numerically and allows the user to select specific data points for further analysis.
Scoring Regression Model Bar Chart (Ranking All Y Variables From 0-1 As	Ranks the variables that form the highest R-squared value with the selected X Variable using a scoring regression model. <u>More information</u> on scoring regression models in Qlik is available here.

Correlation Coefficient	Shows the aggregated correlation coefficient between the X and Y variables as a percentage, with values close to 100% indicating a strong positive correlation, values close to 0% indicating no correlation, and values close to -100% indicating a strong negative correlation. <u>More information on aggregated correlation coefficients in Qlik is available here.</u>
Download Data as CSV	Opens a Comma Separated Values file of the selected and filtered data. Each county is shown as a row and each variable is shown as a column.
